### DISCLAIMER

YOU MUST READ AND ACCEPT THIS DISCLAIMER, AND THE RELATED SUBMISSION GUIDELINES, BEFORE SUBMITTING ANY CONTENT TO TIME FOR ME TV, LLC. BY SIGNING THIS DISCLAIMER, YOU ACKNOWLEDGE THAT YOU HAVE READ, AGREE TO AND ARE IN FULL COMPLIANCE WITH THE TERMS OF THIS DISCLAIMER. THIS WILL ALSO OBLIGATE YOU TO PROVIDE THE MANDATORY FORMS THAT MUST ACCOMPANY ANY SUBMISSION TO TIME FOR ME TV, LLC. TIME FOR ME TV, LLC (hereafter referred to as the "we" or "us", or "Time for Me TV") is accepting submissions of commercial material from members of the public in accordance with the Time For Me TV commercial content submission process.

We are NOT requesting that:

- you or anyone else engage in any activities that may create a risk of harm, loss, physical or mental injury, emotional distress, death, disability, disfigurement, or physical or mental illness to you, to any other person, or to any animal;
- you or anyone else engage in any activities that may create a risk of any other loss or damage to person or property or that you or anyone else violate FCC standards

You agree that you have not engaged nor will you engage in any of the foregoing activities in connection with producing your submission.
